CMS Announces Medicare Advantage Value-Based Insurance Design Model

The Centers for Medicare & Medicaid Services announced the Medicare Advantage Value-Based Insurance Design Model on September 1, 2015. The model aims to improve beneficiary health, reduce the utilization of avoidable high-cost care, and reduce costs for plans, beneficiaries, and the Medicare program. An Analysis Of New York's Medical Home Model

United Hospital Fund published a report highlighting recent trends and future directions of the medical home model in New York State. Medical homes have spread and evolved throughout the state, and now play a fundamental role in the ongoing work toward reforming New York's healthcare system. The "next-generation" of medical home models, also known as Advanced Primary Care, will continue to encourage practices to improve patient outcomes by exceeding NCQA criteria.
