 - o Approved

- o License individual vs business
 - Business is license and hire certified people
 - Responsible person is the one responsible for the employee
 - Business will have the insurance policy
 - Advantage to license individuals is to track the person, where they work
 - DEC Vapor mitigation input, Eric Hausamann
 - Standby consultants/ contractors to subcontract the mitigators for installation and repair
 - o Inspects and reports back
 - Refer to DOH listing, may need to change language as program progress
 - George S. sees vapor intrusion becoming part of AARST standards
 - Vapor intrusion testing is testing for sub slab depressurization
 - 15-20 installations by DEC
 - DEC will give input for report
- Review Draft Task Force Report
 - Review of Advantages/Disadvantages of each agency
 - o Department of Health
 - DOH includes Bureau of Environmental Radiation
 - Already oversees radon program
 - Has licensing program for radioactive material and radiation-producing equipment
 - Review of individual license techs refers to the state ed and federal standards
 - Collects fees
 - Continuing Education requirement
 - Did not require to stay with professional society group
 - Rely on external requirements, education for certification and license
 - Enforcement capabilities
 - Process through AT-10 process
 - Limited power due to radon not an immediate health threat
 - Inspection driven vs complaint driven
 - o ELAP inspects labs including testers who use continuing radon testing
 - Use state agency employee's vs contract inspectors (program in Indiana)
 - Important to have enforcement over unlicensed people and improper installed mitigations. Ensure compliance
 - Add narrative of minimal standards and law proposal
 - o Authorization of surveillance program as needed
 - Idea proposal to inspect firs few installations then % afterwards
 - One paragraph for unlicensed person another for poor performance/ ethical/ removal of license and penalties
 - Third party inspections and examples of programs and AARST
 - Advantages

- Has radon training and outreach. Knowledge of testing and mitigation requirements, but no direct experience with installation of mitigation and testing
- List of certified testers/mitigators is currently volunteered. Requested and submit proof of certification
- Listed certified person is required to report how many test/mitigations done in each county
- Express more details of AT-10 process
- Disadvantages
 - "Establish a separate programmatic effort to license radon testing and mitigation" an issue for all agencies
- o Department of Labor
 - Similar programs oversee license mold and asbestos contractors
 - How does DOL interface with/enforce OSHA regs. With worker exposure?
 - No experience in radiation
 - State and Labor may have oversight of a business pending home inspection, mold testing etc.
 - Advantages
 - May be dealing with many of same companies
 - Disadvantages
 - Lack enforcement capability
 - Would hire new staff or train existing staff in radon
- o State Education Department
 - License individuals that require approved higher education
- o Department of State
 - Will need further review from John and Whitney
 - What enforcement does DOS have?
 - Process for code violation?
