Building High-Performance Teams to Tackle Sudden Cardiac Arrest

With only minutes making the difference between a patient's life and death, Sudden Cardiac Arrest highlights the need for the best team performance possible. This is true whether you work in a hospital or pre-hospital environment. In this hands-on interactive course you will see how team performance in resuscitation can instill saving lives into part of a team's character. You will experience how simulation can lead to improved individual competency, team coordination, team aggressiveness, and team familiarity with a process. You will also discover how simulation can help teams develop situational awareness, overcome the unexpected, and develop the adaptive behavior necessary when things don't go as planned.

Who should attend? This class is designed for pre-hospital and hospital providers and/or educators. The richness of the learning experience will only benefit from having the broadest audience possible. Attendees will learn how to:

- Use science-based measurement, assessment, and feedback to improve CPR skills and maintain competency
- Plan for team roles, responsibilities, and processes, using simulation as your proving ground
- Practice for leadership and followership skills, plus the common team language and standardized practices that go with it
- Access the ever-changing environment to develop situation awareness
- Foster assertive patient safety-centric communications when risks occur
- Change the team or environment mix to promote adaptive behavior
- Pinpoint system-designed errors and environment-driven errors

Class Structure: This session will require significant hands-on activity. Attendees can choose to serve on actual teams or serve as coaches providing assessment and feedback. Class limited to 30 students. (NYS CME: All Levels – Shock and Resuscitation/Cardiology)

Participants will utilize high-fidelity, computerized life-like manikins in real-life scenarios in a controlled setting for optimal learning. You will have hands-on practice to review and improve your physical skills, along with problem solving and teamwork skills. The sessions will begin with classroom review of objectives, anatomy and physiology, learning points and overview of the facility. Your journey through the world of simulation will be guided by

highly trained facilitators who are educated to work with adult learners in a simulated teaching environment. Facilitators will lead participants through predetermined patient scenarios that are designed to challenge your knowledge and make the team work together for a successful patient outcome. One scenario will be treating a patient with a Left Ventricular Assist Device (LVAD). A formal debriefing will follow each scenario, which will include video playback, group discussions and team work.

Cardiac Arrest Management

Cardiac arrest situations require a careful orchestration of many EMS skills: chest compressions, airway access, ventilatory control, vascular access, electrical therapy, circulatory support, dysrhythmia management and the ability to think fast on your feet! The steps are well articulated in algorithms and classes across the country, but are they always applied appropriately or effectively? Why is uninterrupted, quality CPR using a Pit Crew approach essential and how can that best be achieved? What airway access methods are most practical and useful? How can we optimize confirmation of effective ventilations? How can EMS personnel administer drugs and perform rapid defibrillation on a timely basis? Should we be using devices to enhance cardiac compressions and improve circulation? Should we be resuscitating the patient at all? What if we achieve ROSC? What therapies are indicated? These questions and more will be discussed in a case-based approach to treating the pulseless patient. (NYS CME: Shock & Resuscitation/Cardiology)

Emotional and Social Intelligence: Hillbilly Heaven

Included in this presentation will be the proper identification of events that require EMS presence, gauging the appropriate level of staffing, pre-planning of operations, logistics and support, as well as patient care considerations. Having your EMS personnel out in the community is a positive in many ways, but can be fraught with pitfalls if you do not prepare for them. Mr. Romano will engage the audience in a complete review of preparedness from the local football game to a large scale event. (NYS CME: All Levels – Additional)

Assessing and Treating Altered Mental Status as an EMT: It's More Than Calling ALS

EMTs play an important role in any EMS system, but in many situations, their valuable skill set is ignored in a rush to bring paramedics to the scene. Although most protocols traditionally call for an ALS response to altered mental status, there are important assessment and treatments steps that need to occur before the paramedic arrives. This class will review the assessment of altered mental status and discuss critical decision-making in the context of a decreased level of consciousness. We will further review the common causes of altered mental status and describe lifesaving basic interventions. This session will cover Rapid Sequence Intubation from the perspective of not only procedure and drug choices, but also the QI and legal implications of misplaced ET tubes. This session will focus on adult RSI, but will also consider pediatric literature. RSI is not the latest and greatest toy, but a very special tool that has significant ramifications for the underprepared user.

Objectives:

- List various drugs used for sedation and induction of paralysis in RSI.

A patient wears this lightweight garment that has built in electrodes for constant monitoring of the heart and therapy pads for immediate therapy (treatment shock) if a life-threatening ventricular arrhythmia is detected (VT or VF) with no bystander assistance. The community is seeing a larger number of patients wearing these devices at home as individuals are discharged from the hospital given their risk of sudden cardiac arrest after a heart attack, post bypass or CHF, to name a few conditions. The goal of this presentation is to educate the audience on the device as they arrive to a patient's home who has a LifeVest on and inform how to decide if it needs to stay on or be removed given the alerts coming from the device.
