- The New York Chapter of the American College of Physicians Hosts CPC+ Webinar
  NYACP hosted an informational webinar for providers surrounding the Centers for Medicare and Medicaid's
  Comprehensive Primary Care Plus (CPC+) initiative. NYACP was joined by the NYS Department of Health and
  a number of commercial insurers to provide further details on this opportunity. Practices that would like to

- New York Health Records Database Reaches 9 Million Patients

  The State Health Information Network for New York (SHIN-NY) is a mostly state-funded project that facilitates record-sharing among providers with patient consent. The SHIN-NY handles more than 2.8 million transactions per month and is used by 62,000 medical providers. The project is now expected to produce savings more than triple the estimated \$70 million annual operating cost. Further information is available here.
- New York's Proposes All Payer Database Regulations

The Department of Health presented new regulations for the state's all-payer database (APD) at the August meeting of the state's Public Health and Health Planning Council. The proposed regulations would allow collection of public and private health claims and eligibility data from insurance carriers, health plans, third party administrators, Medicaid, and Medicare. The U.S. Supreme Court recently ruled that self-insured employer health plans cannot be required to submit claims data. The Department will accept public comment on the proposed regulations through October 17, 2016 – instructions for submitting comment are available at the end of the proposed regulations.  New York City Population Health Improvement Program Publishes Strategy for Expanding Medical Home Model Across NYC

The New York City Population Health Improvement Program (PHIP), in partnership with the United Hospital Fund, released a strategy for expanding the Medical Home model across the City. Emphasizing expanding primary care access and quality, the strategy includes a goal of having 80% of primary care providers located in NYC reach medical home status by 2020 – through NCQA recognition, participation in Advanced Primary Care (APC), or participation in the Transforming Clinical Practice Initiative (TCPI). The strategic plan articulates the core principals behind primary care expansion in NYC, and a set of actionable steps to achieve the 80% goal.  National Business Group on Health Survey Reveals Most Large Employers Will Offer Telehealth Next Year

A new report from the National Business Group on Health indicates that 9 out of 10 large employers in states where telemedicine is legal will make telehealth services available to their employees next year. The survey has found an increasing percentage of large employers offer telehealth services – the National Business Group

predicts that by 2019, 97 percent of large employers will offer telehealth services. Further information is available here.

## National Commission on Certification of Physician Assistants (NCCPA) Releases First-Ever Report on Workforce Data

The NCCPA released its first-ever report on workforce data across 22 specialties. Their data suggests that nearly 70% of physician assistants are working in settings other than primary care. Further, the PA workforce is relatively young, with a median age of 38; less than one percent of PAs indicated they planned to retire in the current year.
