Medicaid Updates: State Plan Amendment Federal Public Notice (FPN)

- The FPN will be published in December 2023.
- NYS Medicaid will circulate the FPN link to listserv members and post on the doula services website.
- The FPN comment period will remain open until CMS approves the State Plan Amendment

Medicaid Updates, Continued: Child Welfare/Parenting Supports

- Doulas will not be required to complete mandatory reporter training as they will not be designated as mandatory reporters.
- Doulas will be encouraged to complete the mandatory reporter training to become familiar with the child welfare process and parent supports.
- Resources will be included in the Doula Services Provider Manual.
- The Doula Services Provider Manual will be published with the State Plan Amendment approval.

Medicaid Updates, Continued: Doula Directory

- A doula directory was developed and maintained for the Medicaid Doula Services Pilot:

- DOH has started work on the development of a statewide doula services directory to support implementation of the statewide doula services benefit, in alignment with the recently enacted legislation.
- The statewide doula directory will go live upon SPA approval
