** Direct Billed Members are identified in the Health Home Tracking System with a value of "Y" for the Direct Bill Indicator. A direct bill indicator of "Y" in the tracking system indicates that the Health Home member is receiving services with a converting Care Management Agency (CMA). The "Y" messages to the Health Home and the Managed Care Plan that the CMA bills Medicaid directly. Members in the "Incorrect Billing Prov" represent members with claims where the billing provider ID does not match the CMA provider ID reported in the tracking system. means that the Health Home or the MCP bills Medicaid for Health Home services. If the member is in a plan, the plan bills Medicaid and if the member is FFS, the Health Home bills Medicaid.
