Dr. McDonald's goal is to eliminate health disparities, noting alignment with goals of the Health Equity Council.

Council Business	<ul> <li>Ms. Morne stated that the goal for the Office of Health Equity and Human Rights (OHEHR) is to form a partnership with all the departments within the Department of Health, state agencies and community stakeholders across New York State. Ms. Morne noted that is not only about creating change, but rather the goal is to impact sustainable change that can impact and benefit people's lives.</li> <li>Ms. Morne highlighted the New York State Hepatitis C elimination progress report that was released at a public meeting held on May 10, 2023. The work was done over the last 2 - 3 years by a Hepatitis C Task Force. The Task Force was charged with developing recommendations and providing guidance the elimination of hepatitis C across our state by 2030.</li> <li>Ms. Morne mentioned that the OHEHR has launched the first ever New York State Congenital Syphilis Elimination Strategic Planning Group to address the increasing rates of congenital syphilis.</li> <li>Ms. Morne acknowledged that is June is National Gun Violence Awareness Month. The DOH, Office of Gun Violence Prevention works very closely with the Division of Criminal Justice Services (DCJS) to identify and provide community stakeholders with access to resources, technical assistance and overall support.</li> </ul>
Presentations	<ul> <li>Health Equity Impact Assessment, Tina Kim, Deputy Director for the Office of Health Equity and Human Rights, Kacey Griffin, Health Program Coordinator (NYSPHC Fellowship Program)         <ul> <li>New York State legislation S1451A/A191 requires a Health Equity Impact Assessment (HEIA) to be filed with a Certificate of Need (CON) application for the establishment, ownership, construction, renovation, and change in service of health care facilities across New York State, which will provide information on whether a proposed project impacts the delivery of or access to services for the service area, particularly medically underserved groups. The Health Equity Impact Assessment requirement ensures that community voices are considered as well as an objective, independent assessment of the anticipated impact of the project on the public health of, service delivery of, or access to hospital and health-related services for medically underserved groups. The legislation was signed into law on December 22, 2021. The Health Equity Impact Assessment requirement is effective June 22, 2023. The purpose of the Health Equity Impact Assessment is to demonstrate how a facility's proposed project affects the accessibility and delivery of services, and whether the project will enhance health equity and contribute to mitigating health disparities in the project's service area, specifically for medically underserved groups.</li> </ul> </li> </ul>
	<ul> <li>Addressing Hunger within Our Communities, Dan Irizarry, Chair, Capital District Latinos, Micky Jimenez, Capital District, Latinos, Cassie Andrusz- Ho Ching Ph.D., Capital District Latinos</li> <li>Capital District LATINOS (CDL) provided a presentation to the HEC concerning its history, mission and current operations. CDL, founded in 2011, seeks to "create the conditions for success" in the Latino community of the Capital District; since its inception, has focused on addressing the social determinants of health with a person-centered, trauma informed approach. They have worked to provide a safe place for all members of our community, regardless of immigration status, color, gender or creed. CDL operates out of the Cultural Empowerment &amp; Community Engagement Center at 160 Central Ave. in Albany, where they operate a clothing distribution program, a culturally appropriate food pantry, and provide case management and cultural programming.</li> </ul>
