MINIMUM QUALIFICATIONS	<p>Open to NYS Employees: Current NYS employee and eligible to transfer under Section 70.1 or 70.4 of the Civil Service Law.</p> <p>Open to the Public: Applicants not currently in a permanent Licensed Practical Nurse title or on the eligible list, must meet one of the following qualifications:</p> <ol style="list-style-type: none">1. A license to practice as a practical nurse in New York State2. A limited permit to practice as a practical nurse in New York State3. An application on file for a limited permit to practice as a practical nurse in New York State. (You must be appointed immediately following graduation from an approved school of practical nursing to qualify under this option.) <p>Note: If you are appointed with either qualification 2 or 3, you must obtain your license within one year of the date your limited permit was issued or the appointment will be voided. Continued employment will be contingent upon maintaining a valid NYS license to practice as a Practical Nurse.</p>
PREFERRED QUALIFICATIONS	Preference will be given to candidates with long-term care experience.
RESPONSIBILITIES	As a LPN under the supervision of an RN, you would be involved in the treatment of residents. You would administer certain medications; observe residents and report changes in their condition; take and record temperature, pulse, respiration and blood pressure; and obtain specimens for analysis. You would prepare and apply simple dressings; bathe and feed residents; and care for residents and their quarters by performing such tasks as making beds, changing linen, lifting and moving residents and caring for their personal effects.
CONDITIONS OF EMPLOYMENT	Permanent or Contingent Permanent appointments.
APPLICATION PROCEDURE	NYS employees eligible for transfer must complete an Employment Application. Open Competitive candidates must complete an Employment Application and NYS-APP to be rated and placed on the Home's eligible list for LPN until filled.
