RESPONSIBILITIES	The incumbent will be responsible to review prior approval requests and issue denials as indicated, provide medical expertise in support of daily activities involving prior approval of certain Medicaid reimbursable goods and services in the Medical Indemnity Fund; adjudicate claims pending for manual review and pricing, review specific coverage, enrollment and coding issues; examine patient records; assess the quality of patient care received; prepare written reports on provider adherence to requirements of the Medicaid Program; and provide oral testimony at hearings on the State's behalf.
