On June 5, 2013, the New York State Department of Health (“NYSDOH”) distributed a *State Environmental Quality Review (“SEQR”) Positive Declaration Notice of Intent to Prepare a Draft Environmental Impact Statement Determination of Significance and Notice of Public Scoping Session on Draft Scoping Document* for the Jewish Home Lifecare, Manhattan Replacement Nursing Facility Project (the “Proposed Project”).
