## Commissioner's Determination on Acute Labor Supply Shortage Pursuant to 10 NYCRR 415.13(f)(2)(ii)(b)(1)

June 22, 2023

Pursuant to  $\underline{10 \text{ NYCRR § } 415.13(f)(2)(ii)(b)(1)}$ , I hereby issue this determination of an acute labor supply shortage of nurse aides, certified nurse aides, licensed practical nurses, and registered nurses in the Metropolitan and Nonmetropolitan Areas of New York State, for the reasons specified below.

## **Determination:**

On September 27, 2021, Governor Hochul issued Executive Order No. 4, declaring a *Statewide Disaster Emergency Due to Healthcare Staffing Shortages in the State of New York*. Due to the continuing staffing shortages in hospitals and other healthcare facilities, the State disaster emergency was continuously in effect from April 1, 2022 to December 31, 2022, (the second, third, and fourth quarters of 2022), through the issuance of Executive Orders 4.7, 4.8, 4.9, 4.10, 4.11, 4.12, 4.13, 4.14, 4.15, and 4.16.

Having consulted with representatives of the New York State Department of Labor and reviewed relevant data on the labor market, I conclude that Executive Orders 4.7, 4.8, 4.9, 4.10, 4.11, 4.12, 4.13, 4.14, 4.15, and 4.16 support the determination that healthcare facilities, including residential health care facilities licensed by the State of New York in all Metropolitan and Nonmetropolitan Areas of New York State, were located in an area experiencing an acute labor supply shortage during the second, third and fourth quarters of 2022.

Accordingly, based on the above and for the purpose of making a determination pursuant to Public Health Law § 2895-b and 10 NYCRR § 415.13(f), I hereby determine that there was an acute labor supply shortage for the types of personnel referenced below in the Metropolitan and Nonmetropolitan Areas of New York State, as defined by the federal Bureau of Labor Statistics (BLS) and outlined below.
