Section 4.2 Bid Requirements is amended as detailed below:

a. Cereal Varieties

The bidder must provide a minimum of three (3) two (2) types of dry, plain infant cereal, including:

- Single grain rice
- Single grain oatmeal
- A minimum of one additional variety (for example which must be rice, barley, whole wheat, or multi-grain etc.)

d. Product Exclusions

- Infant cereals containing infant formula, milk, fruit, or other non-cereal ingredients are not allowed.
- Containers with individual serving packets will not be considered.
- Corn based infant cereal is not a WIC eligible food item.

Section 4.7 Payment is amended to add the paragraph below:

The Department will provide refunds of rebates to the vendor in the event that a final administrative or judicial determination is reached that a retailer engaged in actionable fraud involving the vendor's product(s) and, on that basis, the Department engaged in successful claims collections. However, please note that no Department records pertaining to a compliance buy or investigation process, made pursuant to any federal or state requirement, will be provided to the vendor under the terms of this contract. Such records may be shared with and evaluated by law enforcement entities and must be kept strictly confidential.
