#### 2. OVERVIEW

Through this Invitation For Bids ("IFB"), the New York State ("State") Department of Health ("DOH") is seeking competitive bids from qualified organizations for the delivery of Dry Ice Pellets for use within laboratory settings for the storage and delivery of scientific materials at a temperature of -90F, as further detailed in <a href="Section3">Section 3</a> Detailed Specifications. It is the Department's intent to award a five-year Purchase Authorization (PA) contract agreement from this procurement.

#### 2.1. Introductory Background

DOH Wadsworth Center Laboratories is a science-based community committed to protecting and improving the health of New Yorkers through laboratory analysis, investigations and research, as well as laboratory certification and educational programs. As the state's public health reference laboratory, Wadsworth responds to urgent public health threats as they arise, develops advanced methods to detect microbial agents and genetic disorders, and measures and analyzes environmental contaminants.

#### 2.2. Important Information

It should be noted that Attachment L, Appendix A "Standard Clauses for New York State Contracts" contains important information related to the contract to be entered into as a result of this IFB and will be incorporated, without change or amendment, into the contract entered into between DOH and the successful Bidder. By submitting a response to the IFB, the Bidder agrees to comply with all the provisions of Appendix A.

Attachment A, the "Bidder's Certified Statements" should be submitted and includes a statement that the

bidder accepts, without any added conditions, qualifications or exceptions, the contract terms and conditions contained in this IFB including any exhibits and attachments.

## 2.3. Term of the Agreement

This contract term is expected to be for a period of five-years commencing on the date shown on the Calendar of Events in <u>Section 1</u> subject to the availability of sufficient funding, successful contractor performance, and approvals from the New York State Attorney General (AG) and the Office of the State Comptroller (OSC).

### 2.4. Minimum Qualifications

Bidder is required to have a minimum of three years' experience with industrial delivery of Dry Ice Pellets.

Bidder should provide references using <u>Attachment E</u> (References) to list firm names, addresses, contact names, telephone numbers, and email addresses.

Failure to meet the Minimum Qualification will result in a bid being found non-responsive and eliminated from consideration.

## 2.5. Mandatory Site Visit

Bidders can only attend one (1) day of the two (2) scheduled Mandatory Site Visit. Bidders will be required to attend and sign in at each location (noted below) during their scheduled visit:

As noted within <u>Section 3.3</u> Estimated Quantities and Delivery Requirements, there are four (4) separate DOH Wadsworth Center locations requiring delivery of Dry Ice Pellets. Only two (2) locations (listed above) will be visited during the Mandatory Site Visit.

The schedule for the Mandatory Site Visit is provided in <u>Section 1.0</u> Calendar of Events. Registration for Site Visit is required.

  - Any questions that cannot be answered during the Mandatory Site Visit will be answered and incorporated into the Department's official response to questions and posted to the Department's website, on or about the date specified in Section 1.0 Calendar of Events.
- Vendors should clearly understand that the only official answers or positions of the Department are
  those stated in writing and posted on the Department's website for this IFB. Verbal responses
  provided during the mandatory Site Visit (or at any other time) do not represent the official answer
  or position of the Department and the Department shall not be bound in any way by any such verbal
  answer.

#### 3. DETAILED SPECIFICATIONS

This section describes the requirements of the Dry Ice Pellets to be provided by the selected bidder. The selected bidder must be able to provide all requested product and service throughout the five-year contract term.

The following specifications refer to the first year of the contract. Quantity for all subsequent years is estimated to be largely the same. However, NYS DOH reserves the right to change, add or remove delivery locations, days and times of delivery, and the number of bins at each facility throughout the subsequent years of the contract.

## 3.1. Bid Requirements

Bidder must provide a per pound delivered price inclusive of each sub-section listed in <u>Section 3</u> Detailed Specifications, including all shipping, handling and freight charges as defined in <u>Section 3.3</u> Estimated Quantities and Delivery Requirements, and all other un-defined costs associated with the manufacturing, and delivery of Dry Ice Pellets, to be completed using <u>Attachment C</u>, (BID FORM) of this IFB and submitted according to <u>Section 5</u> Bid Format and Content.

#### 3.2. Product or Service Requirement

Bidder will be required to perform inside delivery of Dry Ice Pellets one to two times per week during normal business hours, Monday through Friday, at four separate DOH Wadsworth Center facility locations. Contractor must be able to perform the following:

- Dry Ice Pellets must be delivered in bins that are insulated with lids and wheel mounted for ease
  of mobility.
- Dry Ice Pellets must be transferred by Contractor into bins owned by DOH Wadsworth, which are located on-site at each facility.
- Dry Ice Pellets must be accurately weighed and recorded by Contractor upon delivery. DOH
  Wadsworth will periodically audit delivery weights to ensure accuracy of Contractor's chosen
  method of recording delivered weights.
- Contractor personnel entering any DOH Facility must wear a uniform, consisting of at minimum, a shirt identifying them as an employee of the Contractor's business entity. No shorts, tank-tops or cut off sleeves will be permitted.

- The vendor's delivery personnel will be provided DOH Wadsworth Center (WC) ID badges at no charge to the vendor. The badges must be displayed on their person at all times when on WC grounds or in a WC facility and must not be displayed at any other time. The vendor is responsible for returning badges of personnel whose employment is terminated for any reason within 24 hours of termination to the WC Contract Manger.
- The DOH Wadsworth Center reserves the right to reject any employee of the contractor at any time and require their immediate replacement with staff acceptable to the WC Contract Manager.

## 3.3. Estimated Quantities and Delivery Requirements

**Regular Weekly Delivery:** Schedules for all four locations will be Monday through Friday, between 8:00 AM and 3:30 PM. Estimated usages and delivery location details are indicated in the chart below. Scheduled deliveries that fall on a State Holiday will be required to deliver the next business day.

**Emergency Situations** and **Scheduled Power Shutdowns:** Upon request, the contractor will be required to deliver up to 5 insulated bins with lids that are wheel mounted. The bins measurements are to be approximately 43" x 27" x 40", hold a minimum of 500lbs and be filled to maximum capacity with dry ice pellets upon delivery. The delivered bins will remain on-site at DOH until all product has been exhausted, at such time Contractor will remove said bin(s) during regular scheduled weekly deliveries.

- Emergency Situations: During such events Contractor must be able to deliver the requested number of filled bins within 8 hours and be able to deliver during off hours including nights, weekends and holidays. DOH Wadsworth will adjust facility delivery times as deemed necessary.
- **Scheduled Power Shutdown:** DOH Wadsworth will notify Contractor a minimum of 7 days prior to scheduled shutdowns. Delivery of the requested number of filled bins will be required on a regularly scheduled business day.

Any unused dry ice pellets delivered during such events will be used by the contractor to fill regular weekly scheduled deliveries. Once product has been exhausted, Contractor will remove their bin(s) and resume regular product fill and delivery.

#### 4. ADMINISTRATIVE INFORMATION

The following administrative information will apply to this IFB. Failure to comply fully with this information may result in disgualification of your bid.

#### 4.1. Restricted Period

"Restricted period" means the period of time commencing with the earliest written notice, advertisement, or solicitation of a Request for Proposals ("RFP"), Invitation for Bids ("IFB"), or solicitation of proposals, or any other method for soliciting a response from Bidders intending to result in a procurement contract with DOH and ending with the final contract award and approval by DOH and, where applicable, final contract approval by the Office of the State Comptroller.

This prohibition applies to any oral, written, or electronic communication under circumstances where a reasonable person would infer that the communication was intended to influence this procurement. Violation of any of the requirements described in this Section may be grounds for a determination that the bidder is non-responsible and therefore ineligible for this contract award. Two violations within four years of the rules against impermissible contacts during the "restricted period" may result in the violator being debarred from participating in DOH procurements for a period of four years.

Pursuant to State Finance Law §§ 139-j and 139-k, the Department of Health identifies a designated contact on face page of this IFB to whom all communications attempting to influence this procurement must be made.

#### 4.2. Questions

There will be an opportunity available for submission of written questions and requests for clarification pertaining to this IFB. All questions and requests for clarification of this IFB should cite the relevant IFB number, section and paragraph number where applicable, and must be submitted via email to

<u>robert.miller@health.ny.gov</u>. It is the bidder's responsibility to ensure that emails containing written questions and/or requests for clarification is received at the above address no later than the Deadline for Submission of Written Questions as specified in <u>Section 1</u> Calendar of Events. Questions received after the deadline may **not** be answered.

## 4.3. Right to Modify IFB

DOH reserves the right to modify any part of this IFB, including but not limited to, the date and time by which bids must be submitted and received by DOH, at any time prior to the Deadline for Submission of Bids listed in <u>Section 1</u> Calendar of Events. Modifications to this IFB shall be made by issuance of amendments and/or addenda.

If the bidder discovers any ambiguity, conflict, discrepancy, omission, or other error in this IFB, the Bidder shall immediately notify the Designated Contact listed on page one of this IFB of such error in writing and request clarification or modification of the document.

If, prior to the Deadline for Submission of Bids, a bidder fails to notify DOH of a known error or an error that reasonably should have been known, the bidder shall assume the risk of bidding. If awarded the contract, the bidder shall not be entitled to additional compensation by reason of the error or its correction.

#### 4.4. Purchase Orders

Purchase orders are effective and binding upon the contractor's receipt.

In event of a conflict between the purchase order document and any referenced documents contained within the purchase order, bidder agrees to comply with <a href="Attachment M">Attachment M</a> (Notice to Vendors). The order of precedence shall be as follows:

- 1. Appendix A, Standard Clauses for New York State Contracts
- 2. Purchase Order document
- 3. Any agency specific standard clauses
- 4. Agency solicitation document or specifications
- 5. Vendor's offer / bid proposal

#### 4.5. Quantities

The quantities listed are estimated only and are based upon the quantities required for a one-year period. However, the contract shall be for the amount actually ordered during the contract period. The NYS Department of Health reserves the right to increase or decrease quantities as it deems necessary.

#### 4.6. Minimum Order

There is no minimum order.

#### 4.7. Price Changes

First year pricing will be based upon the bid price submitted in response to this IFB. Requests for increase during years 2 through 5 must be submitted 60 days prior to the yearly anniversary of the approved contract start date.

Price increases will be determined by the previous year pricing plus an adjustment of the lesser of five percent (5%) in accordance to the percent change in the Producer Price Index (PPI) by Industry: Industrial Gas Manufacturing: Carbon Dioxide (PCU3251203251204) as published by the United States Bureau of Labor Statistics, Washington, D.C., 20212 for the twelve (12) month period ending three (3) calendar

months prior to the anniversary date for the preceding twelve month period. If the percent change in PPI is less than zero, then pricing will remain the same.

In no event shall more than one request for a price increase be considered during any single year period. Rate decreases are not capped and will be allowed at any time. Rate increases may not exceed five percent.

No additional charges, including fuel surcharges and hazardous material (HAZMAT) handling charges, etc. will be allowed during the entire contract period.

## 4.8. Request for Change

Any request by the agency or contractor regarding changes in any part of the contract must be made in writing prior to effectuation. Such requests are subject to approval by the State Comptroller.

#### 4.9. Termination

The NYS Department of Health reserves the right to cancel the contract upon 30 day written notice for: (1) Unavailability of Funds; (2) Cause; (3) Convenience. Failure of the contractor to provide the required goods in accordance to the contract, the NYS Department of Health reserves the right to cancel the contract upon 30 day written notice. If the agreement is terminated, the NYS Department of Health shall be liable only for payment of goods received prior to the effective date of termination.

### 4.10. Payment

Payment for invoices and/or vouchers submitted by the CONTRACTOR shall only be rendered electronically unless payment by paper check is expressly authorized by the Commissioner, in the Commissioner's sole discretion, due to extenuating circumstances. Such electronic payment shall be made in accordance with ordinary State procedures and practices. The CONTRACTOR shall comply with the State Comptroller's procedures to authorize electronic payments. Authorization forms are available at the Comptroller's website at http://osc.state.ny.us/vendors/epayments.htm State bγ epayments@osc.state.ny.us or by telephone at 518-474-6019. CONTRACTOR acknowledges that it will not receive payment on any invoices and/or vouchers submitted under this Contract if it does not comply with the State Comptroller's electronic payment procedures, except where the Commissioner has expressly authorized payment by paper check as set forth above. Payment of such invoices and/or vouchers by the State (NYS Department of Health) shall be made in accordance with Article XI-A of the New York State Finance Law.

Note: Payments cannot be processed by the NYS Department of Health until the contract items have been delivered in satisfactory condition. Payment will be based on an invoice used in the supplier's normal course of business and must contain sufficient data including, but not limited to, contract number., purchase order number, description of material, quantity, unit and price per unit, as well as NYS Vendor ID.

## 4.11. Executive Order No. 177 (EO 177) Certification

The New York State Human Rights Law, Article 15 of the Executive Law, prohibits discrimination and harassment based on age, race, creed, color, national origin, sex, pregnancy or pregnancy-related conditions, sexual orientation, gender identity, disability, marital status, familial status, domestic violence victim status, prior arrest or conviction record, military status or predisposing genetic characteristics.

The Human Rights Law may also require reasonable accommodation for persons with disabilities and pregnancy-related conditions. A reasonable accommodation is an adjustment to a job or work environment that enables a person with a disability to perform the essential functions of a job in a reasonable manner. The Human Rights Law may also require reasonable accommodation in employment on the basis of Sabbath observance or religious practices.

Generally, the Human Rights Law applies to:

- all employers of four or more people, employment agencies, labor organizations and apprenticeship training programs in all instances of discrimination or harassment;
- employers with fewer than four employees in all cases involving sexual harassment; and,
- any employer of domestic workers in cases involving sexual harassment or harassment based on gender, race, religion or national origin.

In accordance with Executive Order No. 177, Bidders responding to this IFB must submit a completed and signed Attachment K (EO 177 Certification) to certify that the Bidder does not have institutional policies or practices that fail to address the harassment and discrimination of individuals on the basis of their age, race, creed, color, national origin, sex, sexual orientation, gender identity, disability, marital status, military status, or other protected status under the Human Rights Law.

## 4.12. Equal Employment Opportunity (EEO) Reporting

By submission of a bid in response to this solicitation, the Bidder agrees with all of the terms and conditions of Appendix A including Clause 12 - Equal Employment Opportunities for Minorities and Women. Additionally, the successful bidder will be required to certify they have an acceptable EEO (Equal Employment Opportunity) policy statement.

Further, pursuant to Article 15 of the Executive Law (the "Human Rights Law"), all other State and Federal statutory and constitutional non-discrimination provisions, the Contractor and sub-contractors will not discriminate against any employee or applicant for employment because of race, creed (religion), color, sex, national origin, sexual orientation, military status, age, disability, predisposing genetic characteristic, marital status or domestic violence victim status, and shall also follow the requirements of the Human Rights Law with regard to non-discrimination on the basis of prior criminal conviction and prior arrest.

The Contractor is required to ensure that it and any subcontractors awarded a subcontract over \$25,000 for the construction, demolition, replacement, major repair, renovation, planning or design of real property and improvements thereon (the "Work"), except where the Work is for the beneficial use of the Contractor, undertake or continue programs to ensure that minority group members and women are afforded equal employment opportunities without discrimination because of race, creed, color, national origin, sex, age, disability or marital status. For these purposes, equal opportunity shall apply in the areas of recruitment, employment, job assignment, promotion, upgrading, demotion, transfer, layoff, termination, and rates of pay or other forms of compensation. This requirement does not apply to: (i) work, goods, or services unrelated to the Contract; or (ii) employment outside New York State.

To ensure compliance with this Section, the Bidder should submit with the bid or proposal an Equal Employment Opportunity Staffing Plan <u>Attachment F</u> (Form #4) identifying the anticipated work force to be utilized on the Contract. Additionally, the Bidder should submit a Minority and Women-Owned Business Enterprises and Equal Employment Opportunity Policy Statement <u>Attachment F</u> (Form # 5), to DOH with their bid or proposal.

## 4.13. Sales and Compensating Use Tax Certification (Tax Law, § 5-a)

Section 5-a of the Tax Law, as amended, effective April 26, 2006, requires certain contractors awarded state contracts for commodities, services and technology valued at more than \$100,000 to certify to the Department of Tax and Finance (DTF) that they are registered to collect New York State and local sales and compensating use taxes. The law applies to contracts where the total amount of such contractors' sales delivered into New York State are in excess of \$300,000 for the four quarterly periods immediately preceding the quarterly period in which the certification is made, and with respect to any affiliates and subcontractors whose sales delivered into New York State exceeded \$300,000 for the four quarterly periods immediately preceding the quarterly period in which the certification is made.

This law imposes upon certain contractors the obligation to certify whether or not the contractor, its affiliates, and its subcontractors are required to register to collect state sales and compensating use tax and contractors must certify to DTF that each affiliate and subcontractor exceeding such sales threshold is registered with DTF to collect New York State and local sales and compensating use taxes. The law prohibits the State Comptroller, or other approving agencies, from approving a contract awarded to an offerer meeting the registration requirements but who is not so registered in accordance with the law.

The successful Bidder must file a properly completed Form ST-220-CA with the Department of Health and Form ST-220-TD with the DTF. These requirements must be met before a contract may take effect. ## 4.14. Workers' Compensation and Disability Benefits Certifications

Sections 57 and 220 of the New York State Workers' Compensation Law (WCL) provide that DOH shall not enter into any contract unless proof of workers' compensation and disability benefits insurance coverage is produced. Prior to entering into a contract with DOH, successful Bidders will be required to verify for DOH, on forms authorized by the New York State Workers' Compensation Board, the fact that they are properly insured or are otherwise in compliance with the insurance provisions of the WCL. The forms to be used to show compliance with the WCL are listed below. Any questions relating to either workers' compensation or disability benefits coverage should be directed to the State of New York Workers' Compensation Board, Bureau of Compliance at (518) 486-6307. Failure to provide verification of either of these types of insurance

coverage by the time contracts are ready to be executed will be grounds for disqualification of an otherwise successful Bid.

## 4.14.1. Proof of Workers' Compensation Coverage:

- Form C-105.2: Certificate of Workers' Compensation Insurance issued by private insurance carrier (or Form U-26.3 issued by the State Insurance Fund); or
- Form SI-12: Certificate of Workers' Compensation Self-Insurance (or Form GSI-105.2 Certificate
  of Participation in Workers' Compensation Group Self-Insurance); or
- Form CE-200: Certificate of Attestation of Exemption from New York State Workers' Compensation and/or Disability Benefits Coverage.

## **ONE** of the following forms as Disability documentation:

## 4.14.2. Proof of Disability Benefits Coverage:

- Form DB-120.1: Certificate of Disability Benefits Insurance; or
- Form DB-155: Certificate of Disability Benefits Self-Insurance; or
- Form CE-200: Certificate of Attestation of Exemption from New York State Workers' Compensation and/or Disability Benefits Coverage.

## 4.15. Subcontracting

Bidders may propose the use of a subcontractor. The Contractor shall obtain prior written approval from NYSDOH before entering into an agreement for services to be provided by a subcontractor. The Contractor is solely responsible for assuring that the requirements of the IFB are met. All Contractors shall contain provisions specifying that the work performed by the subcontractor must be in accordance with the terms of the prime contract, and that the subcontractor specifically agrees to be bound by the confidentiality provisions set forth in the agreement between the DOH and the Contractor. DOH reserves the right to request removal of any Bidders staff or Subcontractor's staff if, in DOH's discretion, such staff is not performing in accordance with the agreement. Subcontractors whose contracts are valued at or above \$100,000 will be required to submit the Vendor Responsibility Questionnaire upon selection of the prime contractor.

## 4.16. DOH's Reserved Rights

The Department of Health reserves the right to:

- 1. Reject any or all bids received in response to the IFB;
- 2. Withdraw the IFB at any time, at the agency's sole discretion;
- 3. Make an award under the IFB in whole or in part;
- 4. Disqualify any bidder whose conduct and/or bid fails to conform to the requirements of the IFB;
- 5. Seek clarifications and revisions of bids;
- 6. Use bid information obtained through site visits, management interviews and the state's investigation of a bidder's qualifications, experience, ability or financial standing, and any material or information submitted by the bidder in response to the agency's request for clarifying information in the course of evaluation and/or selection under the IFB;
- 7. Prior to the bid opening, amend the IFB specifications to correct errors or oversights, or to supply

- additional information, as it becomes available;
- 8. Prior to the bid opening, direct bidders to submit bid modifications addressing subsequent IFB amendments:
- 9. Change any of the scheduled dates;
- 10. Eliminate any mandatory, non-material specifications that cannot be complied with by all of the prospective bidders;
- 11. Waive any requirements that are not material;
- 12. Negotiate with the successful bidder within the scope of the IFB in the best interests of the state;
- 13. Conduct contract negotiations with the next responsible bidder, should the Department be unsuccessful in negotiating with the selected bidder;
- 14. Utilize any and all ideas submitted in the bids received;
- 15. Every offer shall be firm and not revocable for a period of three hundred and sixty-five days (365) from the bid opening, to the extent not inconsistent with section 2-205 of the uniform commercial code. Subsequent to such three hundred and sixty- five days (365), any offer is subject to withdrawal communicated in a writing signed by the bidder; and,
- 16. Require clarification at any time during the procurement process and/or require correction of arithmetic or other apparent errors for the purpose of assuring a full and complete understanding of a bidder's bid and/or to determine an bidder's compliance with the requirements of the solicitation.

## 4.17. Freedom of Information Law ("FOIL")

All bids may be disclosed or used by DOH to the extent permitted by law. DOH may disclose a bid to any person for the purpose of assisting in evaluating the bid or for any other lawful purpose. All bids will become State agency records, which will be available to the public in accordance with the Freedom of Information Law. Any portion of the bid that a Bidder believes constitutes proprietary information entitled to confidential handling, as an exception to the Freedom of Information Law, must be clearly and specifically designated in the bid as directed in Section 5.1.6 of the IFB. If DOH agrees with the proprietary claim, the designated portion of the bid will be withheld from public disclosure. Blanket assertions of proprietary material will not be accepted, and failure to specifically designate proprietary material may be deemed a waiver of any right to confidential handling of such material.

### 4.18. Lobbying

Chapter 1 of the Laws of 2005, as amended by Chapter 596 of the Laws of 2005, made significant changes as it pertains to development of procurement contracts with governmental entities. These changes include:

- making the lobbying law applicable to attempts to influence procurement contracts once the procurement process has been commenced by a state agency, unified court system, state legislature, public authority, certain industrial development agencies and local benefit corporations;
- requiring the above mentioned governmental entities to record all contacts made by lobbyists and contractors about a governmental procurement so that the public knows who is contacting governmental entities about procurements;
- c) requiring governmental entities to designate persons who generally may be the only staff contacted relative to the governmental procurement by that entity in a restricted period;
- authorizing the New York State Commission on Public Integrity, (now New York State Joint Commission on Public Ethics), to impose fines and penalties against persons/organizations engaging in impermissible contacts about a governmental procurement and provides for the debarment of repeat violators;
- e) directing the Office of General Services to disclose and maintain a list of non-responsible bidders pursuant to this new law and those who have been debarred and publish such list on its website;

- f) requiring the timely disclosure of accurate and complete information from offerers with respect to determinations of non-responsibility and debarment; (Bidders responding to this IFB should submit a completed and signed Attachment G (Prior Non-Responsibility Determination).
- g) increasing the monetary threshold which triggers a lobbyists obligations under the Lobbying Act from \$2,000 to \$5,000; and
- h) establishing the Advisory Council on Procurement Lobbying.

Subsequently, Chapter 14 of the Laws of 2007 amended the Lobbying Act of the Legislative Law, particularly as it related to specific aspects of procurements as follows: (i) prohibiting lobbyists from entering into retainer agreements on the outcome of government grant making or other agreement involving public funding; and (ii) reporting lobbying efforts for grants, loans and other disbursements of public funds over \$15,000.

The most notable, however, was the increased penalties provided under Section 20 of Chapter 14 of the Laws of 2007, which replaced old penalty provisions and the addition of a suspension option for lobbyists engaged in repeated violations. Further amendments to the Lobbying Act were made in Chapter 4 of the Laws of 2010.

Questions regarding the registration and operation of the Lobbying Act should be directed to the New York State Joint Commission on Public Ethics.

#### 4.19. State Finance Law Consultant Disclosure Provisions

In accordance with New York State Finance Law Section 163(4)(g), State agencies must require all contractors, including subcontractors, that provide consulting services for State purposes pursuant to a contract to submit an annual employment report for each such contract.

The successful bidder for procurements involving consultant services must complete a "State Consultant Services Form A, Contractor's Planned Employment From Contract Start Date through End of Contract Term" in order to be eligible for a contract.

The successful winning bidder must also agree to complete a "State Consultant Services Form B, Contractor's Annual Employment Report" for each state fiscal year included in the resulting contract. This report must be submitted annually to the Department of Health, the Office of the State Comptroller, and Department of Civil Service.

#### 4.20. Debriefing

Once an award has been made, bidders may request a debriefing of their bid. Please note the debriefing will be limited only to the vendor's bid and will not include any discussion of other bids. Requests must be received no later than fifteen (15) business days from date of award or non-award announcement.

#### 4.21. Protest Procedures

In the event unsuccessful bidders wish to protest the award resulting from this IFB, bidders should follow the protest procedures established by the Office of the State Comptroller (OSC). These procedures can be found in Chapter XI Section 17 of the Guide to Financial Operations (GFO). #### 4.22. Iran Divestment Act

By submitting a bid in response to this solicitation or by assuming the responsibility of a Contract awarded hereunder, Bidder/Contractor (or any assignee) certifies that it is not on the "Entities Determined To Be Non-Responsive Bidders/Offerers Pursuant to The New York State Iran Divestment Act of 2012" list ("Prohibited Entities List") posted on the OGS website (currently found at this address: <a href="http://www.ogs.ny.gov/about/regs/docs/ListofEntities.pdf">http://www.ogs.ny.gov/about/regs/docs/ListofEntities.pdf</a>) and further certifies that it will not utilize on such Contract any subcontractor that is identified on the Prohibited Entities List. Additionally, Bidder/Contractor is advised that should it seek to renew or extend a Contract awarded in response to the solicitation, it must provide the same certification at the time the Contract is renewed or extended.

During the term of the Contract, should DOH receive information that a person (as defined in State Finance Law §165-a) is in violation of the above-referenced certifications, DOH will review such information and offer the person an opportunity to respond. If the person fails to demonstrate that it has ceased its engagement in the investment activity which is in violation of the Act within 90 days after the determination of such violation, then DOH shall take such action as may be appropriate and provided for by law, rule, or contract, including, but not limited to, seeking compliance, recovering damages, or declaring the Contractor in default. DOH reserves the right to reject any bid, request for assignment, renewal or extension for an entity that appears on the Prohibited Entities List prior to the award, assignment, renewal or extension of a contract, and to pursue a responsibility review with respect to any entity that is awarded a contract and appears on the Prohibited Entities list after contract award.

## 4.23. Piggybacking

New York State Finance Law section 163(10)(e) (see also <a href="http://www.ogs.ny.gov/BU/PC/SFL.asp">http://www.ogs.ny.gov/BU/PC/SFL.asp</a>) allows the Commissioner of the NYS Office of General Services to consent to the use of this contract by other New York State Agencies, and other authorized purchasers, subject to conditions and the Contractor's consent.

## 4.24. Encouraging Use of New York Businesses in Contract Performance

Public procurements can drive and improve the State's economic engine through promotion of the use of New York businesses by its contractors. New York State businesses have a substantial presence in State contracts and strongly contribute to the economies of the state and the nation. In recognition of their economic activity and leadership in doing business in New York State, bidders/proposers for this contract for commodities, services or technology are strongly encouraged and expected to consider New York State businesses in the fulfillment of the requirements of the contract. Such partnering may be as subcontractors, suppliers, protégés or other supporting roles. All bidders should complete <a href="Attachment H">Attachment H</a> (Encouraging Use of New York Businesses in Contract Performance), to indicate their intent to use/not use New York Businesses in the performance of this contract.

## 5. BID FORMAT AND CONTENT

The following includes the requested format and information that should be provided by each Bidder. Bidders responding to this IFB must satisfy all requirements stated in this IFB. All Bidders are requested to submit complete Bid packages. A bid that is incomplete in any material respect may be rejected.

To expedite review of the bids, Bidders are requested to submit bids as summarized in <a href="Attachment B">Attachment B</a> (Bid Package Checklist). This separation of information will facilitate the review of the material requested. No information beyond that specifically requested is required, and Bidders are requested to keep their submissions to the shortest length consistent with making a complete presentation of qualifications.

DOH will not be responsible for expenses incurred in preparing and submitting the Bid Packages.

#### Such costs should not be included in the Bid.

### 5.1 Bid Package

The purpose of the Bid Package is to demonstrate the qualifications, competence, and capacity of the Bidder to provide the commodity or services contained in this IFB. A Bid Package that is incomplete in any material respect will be eliminated from consideration. The following outlines the required information to be provided, in the following order, by Bidders. The information requested should be provided in the prescribed format. Responses that do not follow the prescribed format may be eliminated from consideration. All responses to the IFB are subject to verification for accuracy.

#### Bid Proposal Packages must include the following to be considered for award:

- 5.1.4. Encouraging Use of New York Businesses in Contract Performance; Submit
   <u>Attachment H</u> (Encouraging Use of New York State Businesses in Contract Performance) to
   indicate which New York State Businesses you will use in the performance of the contract.
- 5.1.5. Vendor Responsibility Attestation and Questionnaire; Complete, certify, and file a New York State Vendor Responsibility Questionnaire. DOH recommends that vendors file the required Vendor Responsibility Questionnaire online via the New York State VendRep System. - **5.1.6. Freedom of Information Law Bid Redactions**; Bidders must clearly and specifically identify any portion of the bid that a Bidder believes constitutes proprietary information entitled to confidential handling as an exception to the Freedom of Information Law. See <a href="Section 4.17">Section 4.17</a>.
- 5.1.7. Vendor Assurance of No Conflict of Interest or Detrimental Effect; Submit Attachment <u>J</u> (Vendor's Assurance of No Conflict of Interest or Detrimental Effect), which includes information regarding the Bidder, members, shareholders, parents, affiliates or subcontractors. Attachment J

must be signed by an individual authorized to bind the Bidder contractually.

- **5.1.8. References**; Provide references using Attachment E (References) for the verification of at least three years' experience with industrial delivery of Dry Ice Pellets. Provide firm names, addresses, contact names, telephone numbers, and email addresses.
- **5.1.9. Equal Employment Opportunity (EEO) Reporting**; Submit a completed Form #4 and Form #5 as directed in Attachment F.
- **5.1.10. Executive Order No. 177 Certification**; Submit Attachment K (EO 177 Certification) to certify that the bidder does not have institutional policies or practices that fail to address the harassment and discrimination of any individuals protected status under the Human Rights Law.

Failure to follow these instructions may result in disqualification.

#### 6. BID SUBMISSION

## 6.1. Submission Requirements

Below outlines the requested format and volume for submission of each part. Bids should be submitted in the form of **SINGLE SIDED**, **2 ORIGINIALS** and **4 COPIES**.

- **6.1.1.** All hard copy bid materials should be printed on 8.5" x 11" white paper (single sided), be clearly page numbered on the bottom of each page with appropriate header and footer information and presented separately in three-ring binders if necessary, A type size of eleven (11) points or larger should be used;
- **6.1.2.** Where signatures are required, the bids designated as originals should have a handwritten signature and be signed in blue ink;
- 6.1.3. The NYSDOH discourages overly lengthy bids. Therefore, marketing brochures, user
  manuals or other materials, beyond that sufficient to present a complete bid, are not desired.
  Elaborate artwork or expensive paper is not necessary or desired. In order for the NYSDOH to
  evaluate bids fairly and completely, bids should follow the format described in this IFB and
  provide all requested information;
- **6.1.4.** Audio and/or videotapes are not allowed. Any submitted audio or videotapes will be ignored by the evaluation team; and

The complete bid must be received by the NYSDOH, no later than the Deadline for Submission of Bids specified in Section 1 Calendar of Events. Late bids will not be considered.

#### 7. METHOD OF AWARD

At the discretion of the Department of Health, all bids may be rejected. The Department will award one contract as described in this IFB to the responsible and responsive bidder who offers the lowest total bid price.

In the event of a tie, the determining factor(s) for award, will be:

The tied bidders will be given the opportunity to provide their best and final bid price to the Department, and after evaluation of these revised bids, the award will then be made to the lowest bidder.

A completed final version of <u>Attachment N</u> (Sample Notice of Contract Award) will accompany the winning bidders letter of award notification and will apply to each subsequent state purchase order placed against the approved contract.

#### 7.1. General Information

At the discretion of the Department of Health, all bids may be rejected. The Department of Health will award the contract to the responsible and responsive bidder who offers the lowest total bid.

Bids that do not meet the minimum qualifications will not be considered for award.

Once a bidder is selected, the Department of Health will issue a contract to the vendor. In order to be considered responsible and responsive, the bid must include all Invitation for Bid (IFB) required documents and meet the minimum qualifications as stated in the IFB.

Bidders may be requested by DOH to clarify the contents of their bids. Other than to provide such information as may be requested by DOH, no Bidder will be allowed to alter its bid after the Deadline for Submission of Proposals listed in Section 1 Calendar of Events.

## 7.2. Submission Review

DOH will examine all bids that are received in a proper and timely manner. The bid containing the lowest total price offered will be further evaluated to determine if it meets all bid submission requirements, as described in <a href="Section 5">Section 5</a> (Bid Format and Content) and <a href="Section 6">Section 6</a> (Bid Submission) for award. That process will be followed until an award is made.

#### 7.3. Award Recommendation

The Evaluation Committee will submit a recommendation for award to the responsible and responsive Bidder with the lowest total bid.

The Department will notify the awarded Bidder and Bidders not awarded. The awarded Bidder will enter into a written Agreement substantially in accordance with the terms outlined and provision of the required service and production as specified in this IFB. The resultant contract shall not be binding until fully executed and approved by the New York State Office of the Attorney General and the Office of the State Comptroller.

#### STANDARD CLAUSES FOR NYS CONTRACTS

The parties to the attached contract, license, lease, amendment or other agreement of any kind (hereinafter, "the contract" or "this contract") agree to be bound by the following clauses which are hereby made a part of the contract (the word "Contractor" herein refers to any party other than the State, whether a contractor, licensee, lessor, lessee or any other party):

- 1. <u>EXECUTORY CLAUSE</u>. In accordance with Section 41 of the State Finance Law, the State shall have no liability under this contract to the Contractor or to anyone else beyond funds appropriated and available for this contract.
- 2. NON-ASSIGNMENT CLAUSE. In accordance with Section 138 of the State Finance Law, this contract may not be assigned by the Contractor or its right, title or interest therein assigned, transferred, conveyed, sublet or otherwise disposed of without the State's previous written consent, and attempts to do so are null and void. Notwithstanding the foregoing, such prior written consent of an assignment of a contract let pursuant to Article XI of the State Finance Law may be waived at the discretion of the contracting agency and with the concurrence of the State Comptroller where the original contract was subject to the State Comptroller's approval, where the assignment is due to a reorganization, merger or consolidation of the Contractor's business entity or enterprise. The State retains its right to approve an assignment and to require that any Contractor demonstrate its responsibility to do business with the State. The Contractor may, however, assign its right to receive payments without the State's prior written consent unless this contract concerns Certificates of Participation pursuant to Article 5-A of the State Finance Law.
- **3.** <u>COMPTROLLER'S APPROVAL</u>. In accordance with Section 112 of the State Finance Law (or, if this contract is with the State University or City University of New York, Section 355 or Section 6218 of the Education Law), if this contract exceeds \$50,000 (or the minimum thresholds agreed to by the Office of the State Comptroller for certain S.U.N.Y. and C.U.N.Y. contracts), or if this is an amendment for any amount to a contract which, as so amended, exceeds said statutory amount, or if, by this contract, the State agrees to give something other than money when the value or reasonably estimated value of such consideration exceeds \$10,000, it shall not be valid, effective or binding upon the State until it has been approved by the State Comptroller and filed in his office. Comptroller's approval of contracts let by the Office of General Services is required when such contracts exceed \$85,000 (State Finance Law Section 163.6-a). However, such pre-approval shall not be required for any contract established as a centralized contract through the Office of General Services or for a purchase order or other transaction issued under such centralized contract.
- **4.** <u>WORKERS' COMPENSATION BENEFITS</u>. In accordance with Section 142 of the State Finance Law, this contract shall be void and of no force and effect unless the Contractor shall provide and maintain coverage during the life of this contract for the benefit of such employees as are required to be covered by the provisions of the Workers' Compensation Law.
- 5. NON-DISCRIMINATION REQUIREMENTS. To the extent required by Article 15 of the Executive Law (also known as the Human Rights Law) and all other State and Federal statutory and constitutional non-discrimination provisions, the Contractor will not discriminate against any employee or applicant for employment because of race, creed, color, sex (including gender identity or expression), national origin, sexual orientation, military status, age, disability, predisposing genetic characteristics, marital status or domestic violence victim status. Furthermore, in accordance with Section 220-e of the Labor Law, if this is a contract for the construction, alteration or repair of any public building or public work or for the manufacture, sale or distribution of materials, equipment or supplies, and to the extent that this contract shall be performed within the State of New York, Contractor agrees that neither it nor its subcontractors shall, by reason of race, creed, color, disability, sex, or national origin: (a) discriminate in hiring against any New York State citizen who is qualified and available to perform the work; or (b) discriminate against or intimidate any employee hired for the performance of work under this contract. If this is a building service contract as defined in Section 230 of the Labor Law, then, in accordance with Section 239 thereof, Contractor agrees that neither it nor its subcontractors shall by reason of race, creed, color, national origin, age, sex or disability: (a) discriminate in hiring against any New York State citizen who is qualified and available to perform the work; or (b) discriminate against or intimidate any employee hired for the performance of work under this contract. Contractor is subject to fines of \$50.00 per person per day for any violation of Section 220-e or Section 239 as well as possible termination of this contract and forfeiture of all moneys due hereunder for a second or subsequent violation.
- 6. WAGE AND HOURS PROVISIONS. If this is a public work contract covered by Article 8 of the Labor Law or a building service contract covered by Article 9 thereof, neither Contractor's employees nor the employees of its subcontractors may be required or permitted to work more than the number of hours or days stated in said statutes, except as otherwise provided in the Labor Law and as set forth in prevailing wage and supplement schedules issued by the State Labor Department. Furthermore, Contractor and its subcontractors must pay at least the prevailing wage rate and pay or provide the prevailing supplements, including the premium rates for overtime pay, as determined by the State Labor Department in accordance with the Labor Law. Additionally, effective April 28, 2008, if this is a public work contract covered by Article 8 of the Labor Law, the Contractor understands and agrees that the filing of payrolls in a manner consistent with Subdivision 3-a of Section 220 of the Labor Law shall be a condition precedent to payment by the State of any State approved sums due and owing for work done upon the project.

NON-COLLUSIVE BIDDING CERTIFICATION.** In accordance with Section 139-d of the State Finance Law, if this contract was awarded based upon the submission of bids, Contractor affirms, under penalty of perjury, that its bid was arrived at independently and without collusion aimed at restricting competition. In accordance with Section 220-f of the Labor Law and Section 139-h of the State Finance Law, if this contract exceeds \$5,000, the Contractor agrees, as a material condition of the contract, that neither the Contractor nor any substantially owned or affiliated person, firm, partnership or corporation has participated, is participating, or shall participate in an international boycott in violation of the federal Export Administration Act of 1979 (50 USC App. Sections 2401 et seq.) or regulations thereunder. If such Contractor, or any of the aforesaid affiliates of Contractor, is convicted or is otherwise found to have violated said laws or regulations upon the final determination of the United States Commerce Department or any other appropriate agency of the United States subsequent to the contract's execution, such contract, amendment or modification thereto shall be rendered forfeit and void. The Contractor shall so notify the State Comptroller within five (5) business days of such conviction, determination or disposition of appeal (2NYCRR 105.4).
- **9. SET-OFF RIGHTS.** The State shall have all of its common law, equitable and statutory rights of set-off. These rights shall include, but not be limited to, the State's option to withhold for the purposes of set-off any moneys due to the Contractor under this contract up to any amounts due and owing to the State with regard to this contract, any other contract with any State department or agency, including any contract for a term commencing prior to the term of this contract, plus any amounts due and owing to the State for any other reason including, without limitation, tax delinquencies, fee delinquencies or monetary penalties relative thereto. The State shall exercise its set-off rights in accordance with normal State practices including, in cases of set-off pursuant to an audit, the finalization of such audit by the State agency, its representatives, or the State Comptroller.
- 10. RECORDS. The Contractor shall establish and maintain complete and accurate books, records, documents, accounts and other evidence directly pertinent to performance under this contract (hereinafter, collectively, "the Records"). The Records must be kept for the balance of the calendar year in which they were made and for six (6) additional years thereafter. The State Comptroller, the Attorney General and any other person or entity authorized to conduct an examination, as well as the agency or agencies involved in this contract, shall have access to the Records during normal business hours at an office of the Contractor within the State of New York or, if no such office is available, at a mutually agreeable and reasonable venue within the State, for the term specified above for the purposes of inspection, auditing and copying. The State shall take reasonable steps to protect from public disclosure any of the Records which are exempt from disclosure under Section 87 of the Public Officers Law (the "Statute") provided that: (i) the Contractor shall timely inform an appropriate State official, in writing, that said records should not be disclosed; and (ii) said records shall be sufficiently identified; and (iii) designation of said records as exempt under the Statute is reasonable. Nothing contained herein shall diminish, or in any way adversely affect, the State's right to discovery in any pending or future litigation.
- 11. IDENTIFYING INFORMATION AND PRIVACY NOTIFICATION. (a) Identification Number(s). Every invoice or New York State Claim for Payment submitted to a New York State agency by a payee, for payment for the sale of goods or services or for transactions (e.g., leases, easements, licenses, etc.) related to real or personal property must include the payee's identification number. The number is any or all of the following: (i) the payee's Federal employer identification number, (ii) the payee's Federal social security number, and/or (iii) the payee's Vendor Identification Number assigned by the Statewide Financial System. Failure to include such number or numbers may delay payment. Where the payee does not have such number or numbers, the payee, on its invoice or Claim for Payment, must give the reason or reasons why the payee does not have such number or numbers.
- (b) Privacy Notification. (1) The authority to request the above personal information from a seller of goods or services or a lessor of real or personal property, and the authority to maintain such information, is found in Section 5 of the State Tax Law. Disclosure of this information by the seller or lessor to the State is mandatory. The principal purpose for which the information is collected is to enable the State to identify individuals, businesses and others who have been delinquent in filing tax returns or may have understated their tax liabilities and to generally identify persons affected by the taxes administered by the Commissioner of Taxation and Finance. The information will be used for tax administration purposes and for any other purpose authorized by law. (2) The personal information is requested by the purchasing unit of the agency contracting to purchase the goods or services or lease the real or personal property covered by this contract or lease. The information is maintained in the Statewide Financial System by the Vendor Management Unit within the Bureau of State Expenditures, Office of the State Comptroller, 110 State Street, Albany, New York 12236.
- 12. EQUAL EMPLOYMENT OPPORTUNITIES FOR MINORITIES AND WOMEN. In accordance with Section 312 of the Executive Law and 5 NYCRR 143, if this contract is: (i) a written agreement or purchase order instrument, providing for a total expenditure in excess of \$25,000.00, whereby a contracting agency is committed to expend or does expend funds in return for labor, services, supplies, equipment,

- 13. <u>CONFLICTING TERMS</u>. In the event of a conflict between the terms of the contract (including any and all attachments thereto and amendments thereof) and the terms of this Appendix A, the terms of this Appendix A shall control.
- **14. GOVERNING LAW.** This contract shall be governed by the laws of the State of New York except where the Federal supremacy clause requires otherwise.
- **15. LATE PAYMENT**. Timeliness of payment and any interest to be paid to Contractor for late payment shall be governed by Article 11-A of the State Finance Law to the extent required by law.
- **16. NO ARBITRATION.** Disputes involving this contract, including the breach or alleged breach thereof, may not be submitted to binding arbitration (except where statutorily authorized), but must, instead, be heard in a court of competent jurisdiction of the State of New York.
- 17. <u>SERVICE OF PROCESS</u>. In addition to the methods of service allowed by the State Civil Practice Law & Rules ("CPLR"), Contractor hereby consents to service of process upon it by registered or certified mail, return receipt requested. Service hereunder shall be complete upon Contractor's actual receipt of process or upon the State's receipt of the return thereof by the United States Postal Service as refused or undeliverable. Contractor must promptly notify the State, in writing, of each and every change of address to which service of process can be made. Service by the State to the last known address shall be sufficient. Contractor will have thirty (30) calendar days after service hereunder is complete in which to respond.
- 18. <u>PROHIBITION ON PURCHASE OF TROPICAL HARDWOODS</u>. The Contractor certifies and warrants that all wood products to be used under this contract award will be in accordance with, but not limited to, the specifications and provisions of Section 165 of the State Finance

Law, (Use of Tropical Hardwoods) which prohibits purchase and use of tropical hardwoods, unless specifically exempted, by the State or any governmental agency or political subdivision or public benefit corporation. Qualification for an exemption under this law will be the responsibility of the contractor to establish to meet with the approval of the State.

In addition, when any portion of this contract involving the use of woods, whether supply or installation, is to be performed by any subcontractor, the prime Contractor will indicate and certify in the submitted bid proposal that the subcontractor has been informed and is in compliance with specifications and provisions regarding use of tropical hardwoods as detailed in §165 State Finance Law. Any such use must meet with the approval of the State; otherwise, the bid may not be considered responsive. Under bidder certifications, proof of qualification for exemption will be the responsibility of the Contractor to meet with the approval of the State.

- 19. MACBRIDE FAIR EMPLOYMENT PRINCIPLES. - 20. <u>OMNIBUS PROCUREMENT ACT OF 1992</u>. It is the policy of New York State to maximize opportunities for the participation of New York State business enterprises, including minority and women-owned business enterprises as bidders, subcontractors and suppliers on its procurement contracts.

#### **DETAILED SPECIFICATIONS**

The purpose of this award is for required weekly scheduled deliveries of Dry Ice Pellets to four separate DOH Wadsworth Center facilities. The following specifications refer to the first year of the contract. Quantity for all subsequent years is estimated to be largely the same. However, NYS DOH reserves the right to change, add or remove delivery locations, days and times of delivery, and the number of bins at each facility throughout the subsequent years of the contract.

#### PRODUCT AND SERVICE REQUIREMENTS

Inside delivery of Dry Ice Pellets will be required one to two times per week during normal business hours, Monday through Friday, at four separate DOH Wadsworth Center facility locations.

- Dry Ice Pellets must be delivered in bins that are insulated with lids and wheel mounted for ease of mobility.
- Dry Ice Pellets must be transferred by Contractor into bins owned by DOH Wadsworth, which are located on-site at each facility.
- Dry Ice Pellets must be accurately weighed and recorded by Contractor upon delivery. DOH Wadsworth will
  periodically audit delivery weights to ensure accuracy of Contractor's chosen method of recording delivered
  weights.
- Contractor personnel entering any DOH Facility must wear a uniform, consisting of at minimum, a shirt identifying them as an employee of the Contractor's business entity. No shorts, tank-tops or cut off sleeves will be permitted.
- The vendor's delivery personnel will be provided DOH Wadsworth Center (WC) ID badges at no charge to the
  vendor. The badges must be displayed on their person at all times when on WC grounds or in a WC facility and
  must not be displayed at any other time. The vendor is responsible for returning badges of personnel whose
  employment is terminated for any reason within 24 hours of termination to the WC Contract Manger.
- The DOH Wadsworth Center reserves the right to reject any employee of the contractor at any time and require their immediate replacement with staff acceptable to the WC Contract Manager.

#### **ESTIMATED QUANTITIES AND DELIVERY REQUIREMNTS**

**Regular Weekly Delivery:** Schedules for all four locations will be Monday through Friday, between 8:00 AM and 3:30 PM. Estimated usages and delivery location details are indicated in the chart below. Scheduled deliveries that fall on a State Holiday will be required to deliver the next business day.

**Emergency Situations** and **Scheduled Power Shutdowns:** Upon request, the contractor will be required to deliver up to 5 insulated bins with lids that are wheel mounted. The bins measurements are to be approximately 43" x 27" x 40", hold a minimum of 500lbs and be filled to maximum capacity with dry ice pellets upon delivery. The delivered bins will remain onsite at DOH until all product has been exhausted, at such time Contractor will remove said bin(s) during regular scheduled weekly deliveries.

- *Emergency Situations:* During such events Contractor must be able to deliver the requested number of filled bins within 8 hours and be able to deliver during off hours including nights, weekends and holidays. DOH Wadsworth will adjust facility delivery times as deemed necessary.
- Scheduled Power Shutdown: DOH Wadsworth will notify Contractor a minimum of 7 days prior to scheduled shutdowns. Delivery of the requested number of filled bins will be required on a regularly scheduled business day.

Any unused dry ice pellets delivered during such events will be used by the contractor to fill regular weekly scheduled deliveries. Once product has been exhausted Contractor will remove their bin(s) and resume regular product fill and delivery.
