4.4 Auto-Assignment Algorithm

EXPLANATION OF AUTO ASSIGNMENT

Pursuant to the terms and conditions of the waiver, individuals required to enroll who do not select a health plan will be auto assigned to a plan.

Specific steps and requirements include the following:

- C An individual will be assigned to a plan only if it is geographically accessible. These standards are described in both the waiver and the State's RFP for plan qualification.
- C An individual will be assigned to a plan only if the plan has sufficient capacity.
- C In the first three years of the program, plans affiliated with Article 28 facilities (predominately prepaid health services plans) will receive 25%, 22¹/₂ and 20% of the initial auto assignments, respectively.
- C The remainder of auto assignments will be distributed evenly among all health plans.

PHSPs will get the first 25% of Auto-Assignments. Persons with a card code of "R" will not be auto assigned (nursing home recipients, etc.).

Reports to the Prepaid Capitation Plans and the local districts will be generated by this process and update the bulletin board as well.
