RE: Clarification #4 for 2020 Quality Assurance Reporting Requirements Technical Specifications

Dear Colleague,

This letter contains information about edits incorporated into the 2020 Quality Assurance Reporting Requirements Technical Specifications and the 2020 NYS Patient-Level Detail (PLD) File Specifications.

The information contained in this clarification has been incorporated into a revised version of the 2020 QARR manual and revised versions of the PLD specifications.

The updated 2020 QARR Manual and the PLD specifications are posted on our Managed Care <u>Information for Health Plans</u> page. The revised specifications should be used in plans' processing for 2020 QARR.

Listed below are the changes and further explanation:

The following edits were made to the 2020 NYS QARR Specifications Manual:

Hybrid Measures (pg. 9-17, Table 1 – QARR List of Requirements)

• Method designation for hybrid measures has been updated to include administrative method.
