Independent Health Presentation

Medicaid Updates: Standing Recommendation

- A request for issuance of a standing recommendation was submitted to the Commissioner.
- There is authority in the New York State Education law for the issuance of only certain specific standing orders, limited to certain vaccinations and testing (TB, HIV, HCV) as well as anaphylaxis and opioid overdose treatments.
- In legal review, it was determined that State legal authority does not exist for standing recommendations for services.
