# NYS Department of Health Health Home Serving Children Training Calendar Announcement

The Department of Health, in collaboration with NYS State Partners and the CANS-NY Technical Institute, would like to announce this training schedule for CANS-NY users. These webinars will meet the NYS DOH inperson training requirements and address training needs to provide support in the use of CANS-NY. There are processes in place during these webinar trainings to ensure accountability to training requirements. NYS DOH will work with lead Health Homes to determine a new target date for all new Health Home staff to be in compliance with the training requirements. The calendar is for November 2020 through March 2021, and more trainings may be released and added to this calendar.

Learners are expected to meet certain requirements in order to receive the certificate of completion for the course, which will be outlined during registration:

- 1. All steps of the course as outlined in the training series must be completed. This includes any independent work assignments such as viewing several short videos and mini vignettes for practice. The training site, TCOMtraining.com, will not grant a completion certificate until all steps are completed. The total time commitment required for full participation is dependent on the training.
- 2. **The webinars must be completed in order**, and all within 30 calendar days of starting this course. Each webinar will be offered on multiple dates, and users may select the offering of their choice. If you attend a Webinar without completing the previous Webinar, you will be asked to leave and attend the requisite Webinars first. Participants should participate in the webinar for the full length of time (no more than 2 hours each).
- 3. Participation in the Webinars will be monitored in several ways, including:
  - a. **Participation in web polls and questions**: Participants are expected to participate fully in polls and interactive group questions. Monitors will be tracking participants' responses to each poll question during the training. Participants must respond to at least 75% of all questions polled during the training to receive full credit for participation.
  - b. **Participation in discussions (chats and group work)**: Participants are expected to participate in discussions via chatting and audio/video sharing within the large group, as well as in the small group activities.
  - c. As mentioned above, participants must complete each self-directed learning assignment as assigned. Participation in additional learning modules will not be permitted if these assignments are not completed inadvance.
  - d. **Attentiveness**: The Zoom software and our live monitors will track attentiveness. Participants who do not appear to be focused will be sent a private chat request with instructions for how to demonstrate attentiveness. After two such requests, we reserve the right to ask you to re-register for the webinar on a future date.

## The training title and the topics they cover are below:

## **CANS-NY Introductory Training**

This course outlines the specifics of the CANS-NY and its use within the Health Home Serving Children system.

Required for Care Managers/CYES Assessors and Supervisors 3 webinars (2 hours each)

## **CANS-NY Supervisory Training**

This course takes a step-by-step look at knowledge and skill development for CANS-NY users and explores supervisory methods that incorporate collaborative assessment.

Required for Care Manager/CYES Supervisors

2 webinars (3 hours each)

## **Building Engagement with Youth and Families**

This course explores approaches for generating engaged and collaborative relationships with youth and families.

This is an optional enrichment course 1 webinar (3 hours)

#### **Lunch and Learn Series**

This series of 1-hour webinar focuses on a new topic each month. This webinar and Q&A will focus on rating the items in on the CANS-NY 0-5/6-21 tool. 1 webinar (1 hour)
