

### HHSC Enrollment by Chronic Condition

The Health Home Serving Children *Enrollment by Chronic Conditions Report* provides a total count of members enrolled in the NYS-DOH Health Homes Serving Children program who are flagged for one or more chronic condition. Asthma, Diabetes, Substance Use Disorder (SUD), and HIV are flagged using the criteria outlined in the Healthcare Effectiveness Data and Information Set (HEDIS). HEDIS is a comprehensive set of standardized measures designed to provide reliable data for healthcare performance improvement. Overweight, Complex Trauma, and Foster Care are flagged by the Medicaid Analytics Performance Portal – Health Home Tracking System (MAPP-HHTS). Serious Emotional Disturbance (SED) and Serious Mental Illness (SMI) is defined by the NYS Office of Mental Health (OMH).

Minimum Health Home enrollment periods e.g., 1 month, are not required for members to be counted in this report. Therefore, **ALL** active enrollment segments are counted for the reporting periods.

**Note:** Counts are not unique. Members with multiple chronic conditions may be included in multiple categories based on the chronic conditions for which they are flagged.

The reporting period is based on a 12-month **Rolling Year (RY)** with an update of 3 months (1 Quarter) for each new report. The reports are identified based on the **first month** of the reporting period.

**For Example:**

1<sup>st</sup> Reporting Period: **RY2017-01 is January 2017– December 2017** – The **01** represents January as this is the first month of the 12-month reporting period

2<sup>nd</sup> Reporting Period: **RY2017-04 is April 2017 – March 2018** – The **04** represents April as this is now the first month of the new 12-month reporting period (This new reporting period contains 3 (three) months of new data Jan – Mar 2018)

## HHSC Enrollment by Chronic Condition

### Please Note:

Claims and Encounter data used for HEDIS defined flags do not identify flagged conditions as a primary or secondary chronic condition. Therefore, the chronic conditions listed above may be primary **or** secondary.

“SS” indicates a small sample size of <30. Health Homes with a chronic condition prevalence of <30 are not reportable.

\*Members in Foster Care are outlined separately for each chronic condition category to which they belong. Foster care members are identified using the Foster Care flag in MAPP\_HHTS which is reported by the Health Home care managers. The Foster Care flag is not a permanent identifier as Health Home members periodically enter and exit the Foster Care program.

\*SED/SMI – OMH definition is reported as a single output flagged by Claims and Encounters data.
