Purpose

- The next several months will have significant activity related to the transition to CCOs
- We need your help and dedication to work in partnership to achieve a smooth transition and ensure individuals receiving services have a positive experience
- We will provide you with information and guidance to share with individuals and families about transitioning to Care Coordination Organizations (CCOs)







Your Role as an MSC

- As an MSC you will have a critical role in informing individuals and families about Care Coordination Organizations (CCO).
- You will also inform them
 of the 2 care management
 options offered by the
 CCO.







The two care management options are:

- The robust and comprehensive Health Home Care Management
- 2. Basic HCBS Plan Support

Both care management options will be provided by (CCOs) across the state.







To do this task effectively, you will need to:

- Understand Health Home Care
 Management and Basic HCBS Plan Support services.
- **Educate** individuals on care management options and benefits.
- Clarify questions to ensure care management decisions are based on informed choice.
- **Support** individuals' care management selection and record it in the OPWDD CHOICES system.
- Obtain consent for chosen care management option
- **Share**, documentation of choice/consent and share current care plan with the CCO..







Materials to Help You

- OPWDD, in collaboration with stakeholders developed a "Toolkit" for MSCs to use as a resource to educate individuals currently receiving MSC and PCSS and to assist them to transition to care management by July 1, 2018
- The toolkit consists of:
 - 1. CCO Informational Brochure
 - 2. Scripts for MSCs to engage and educate individuals.
 - 3. Example Individualized information letter that will go to individuals and families about transitioning to CCO.
 - 4. Documents for the individual's selection of care management.
 - 5. Frequently Asked Questions.

YOU MUST UNDERSTAND

- Effective July 1, 2018, MSC Services will end and new care management services will begin.
- The primary new service will be Health Home Care Management and will provide:
 - coordination of the developmental disability services that individuals and families are currently receiving,

AND

 comprehensive coordination of other health and behavioral health care services individuals may receive.







YOU MUST EDUCATE

Individuals and families about what they need to know about Health **Home Care** Management and Basic **HCBS Support Plan** options.







You Must EDUCATE

- By meeting or speaking with everyone you provide MSC or PCSS services to, BEFORE JULY 1, 2018, to inform them of this new change in service.
- By informing that they will have a care manager and team to rely on throughout the transition.

You will use the Tool Kit Materials to provide this education.







You must CLARIFY

- That OPWDD has enhanced the coordination service by implementing the CCO model and wants people to benefit from this more robust comprehensive service
- That individuals will be able to choose the CCO they want to receive care management from.
- That individuals and families may continue to receive the same services and supports, including self-directed services from their current provider unless they request a change in service and/or service provider.







You must CLARIFY

- That the alternative option of Basic HCBS Plan Support services primarily focuses on planning related to only HCBS services and does not coordinate any other health or behavioral health services.
- That Basic HCBS Plan Support services is similar to PCSS and only requires:
 - Reviewing and updating service plan
 - Ensuring annual LOC completed







Benefits of Health Home Care Management and Basic HCBS Plan Support

Health Home Care Management

- Coordinated OPWDD Supports and Services
- Coordinated Access Behavioral Health Services
- Coordinated Access to Medical, and Dental services
- Identifies Community-Based resources
- Uses technology to Link Services
- Connects Your Care Providers
- Takes Burden of Navigating Systems from Families

Basic HCBS Plan Support

 Develop care plan and review bi-annually



You must SUPPORT

- Individuals to make informed choices using the Informational letter as a guide.
- Individual's enrollment by assisting them to complete the required consent forms.
- Accessing a decision maker if the person is not able to decide independently(future training will be provided)
- A smooth transition to CCO care management services.







You must DOCUMENT

- The individual's (or decision maker) care management choice into the OPWDD CHOICES system to ensure the enrollment process.
- This choice by June 30, 2018, for all individuals receiving MSC or PCSS,

This screen will be available in CHOICES as of 4/15/18.







You must OBTAIN

 The completed consent forms, individual's current service plan and state approved assessment summary, CAS or DDP2.







You must SHARE

- The individual's documentation of choice/consent.
- The individual's current service plan and state approved assessment summary (CAS or DDP2) with their chosen CCO.







Education, Consent, & Enrollment Activities: through July 1, 2018

Consent form is confirmed with choice delineated CCO plan choice is input into CHOICES system to effectuate the enrollment (available 4/15/18)

Individual receives a letter regarding choice made

Choices Selection Screen available in **CHOICES** for MSCs to record individual selection of Health Home or Basic HCBS plan support

OPWDD will send two monitoring reports each week to CCOs/MSC providers to assist in verifying enrollment

Next Steps

- Additional MSC informational sessions will be announced.
- There will be on-line training modules that focus on the IT system as well as more detailed information about the enrollment process.
- Regional Offices will schedule forums for MSC providers and forums for other stakeholders.
