## ADE Forms for 2016 AIU Now Available

Attestation Deadline Extension (ADE) Request Forms can be submitted beginning on June 1, 2017 until June 14, 2017. This form is used to request an attestation deadline extension by providing evidence that extenuating circumstances beyond the provider's control prevented the provider from attesting in MEIPASS by the attestation deadline.

The ADE Request Form must be submitted to HIT@health.ny.gov, within 14 days after the attestation deadline, to be formally considered for an extension by the NY Medicaid EHR Incentive Program and NYS Department of Health (NYS DOH). There will be additional ADE periods for 2015 Meaningful Use (MU) and 2016 Meaningful Use (MU).
