NY Medicaid EHR Incentive Program LISTSERV

Over \$830 Million Paid to NY Medicaid Providers

Since December 2011 the EHR Incentive Program has made over 27,000 payments to Eligible Professionals and Eligible Hospitals in New York State participating in the program. The EHR Incentive Program continues to process payments to those providers who attested to Meaningful Use.

Currently, NY Medicaid is prioritizing the review of 2015 attestations, to ensure that providers who plan to attest to 2016 Meaningful Use have adequate time to submit their attestation. NY Medicaid granted blanket extensions for the 2016 Meaningful Use Payment Year to providers that attested for Payment Year 2015 and did not receive approval before September 1, 2017.
