EP92 Can an Eligible Professional (EP) utilize the same Medicaid Patient Volume (MPV) Reporting Period or overlapping MPV Reporting Periods for multiple Payment Years (PYs)?

EP93 How many years can an Eligible Professional (EP) participate in the NY Medicaid EHR Incentive Program?

EP94 What is the PI reporting period?

Our FAQs are developed based on the feedback and questions that we receive from EPs so, while you're there, take a look at the other questions and see how they can assist you in preparing for your 2018 MU Attestation.

Unsure about your Medicaid Patient Volume (MPV)?
