Preparing for 2018 MU

The New York Medicaid EHR Incentive Program will begin accepting 2018 Meaningful Use attestations in the [MEIPASS](#) system on **July 1, 2019**. Despite this, it is never too early to begin preparing. Here is a quick check list of items for Eligible Professionals (EPs) to complete before attestation time arrives:

CMS Registration: Prior to attesting, verify your CMS registration information is accurate and up to date. If any information needs to be updated, such as email address or telephone number, correct it in the [CMS Registration and Attestation System](#).

Fee-For-Service Enrollment: EPs must be registered as Fee-For-Service Medicaid providers and enrollment must be active throughout the entire attestation, until payment has been processed. For more information visit [eMedNY](#) for more information or call eMedNY Provider Services at 1-800-343-9000.

CEHRT ID: Obtain your EHR Certification ID from the [Certified Health IT Product List](#).

ETIN Certification: EPs must maintain [ETIN certification](#) for Medicaid enrollment and program eligibility.

ePACES: The ePACES username and password are used to submit your attestation online through [MEIPASS](#).

The [MEIPASS](#) system will be open for Payment Year 2018 attestations on **July 1, 2019**. Reminders will be posted to the [NY Medicaid EHR Incentive Program Website](#) and messages will go out to all individuals registered to receive the NY Medicaid EHR Incentive Program LISTSERV.
