NY Medicaid EHR Incentive Program LISTSERV

* Now Accepting Payment Year 2019 Pre-Validations *

Individual and group eligible professionals (EPs) who have already determined their Medicaid Patient Volume may utilize the Pre-Validation services offered by the NY Medicaid EHR Incentive Program. Pre-Validation enables EPs to submit their data for preliminary review before attesting.

Pre-Validation before submitting the completed attestation may subsequently reduce the time of state review.

NOTE: NY Medicaid EHR Incentive Program Support cannot review data until 90 days have passed from the end date of the 90-day Medicaid Patient Volume (MPV) Reporting Period. This period is required to allow Medicaid claims to be processed and finalized. Therefore, providers initiating Pre-Validation with an MPV Reporting Period that ended within the last 90 days will receive notice from the NY Medicaid EHR Incentive Program Support about the inability to review the data.

We recommend selecting an MPV Reporting Period using the prior calendar year method, which prevents the possibility of timing out when using the 12 months before the attestation submission method.
