Pre-Attestation Checklist for 2019

An updated <u>pre-attestation checklist for payment year 2019</u> is now available on the NY Medicaid EHR Incentive Program website. The checklist includes guidance about prerequisites, meaningful use, payment information, and support resources. It is recommended that eligible professionals (EPs) review this checklist to ensure they have met the requirements for payment year 2019.
