# Patient Engagement for Eligible Professionals – February 9, 2021 at 11:00am

Topics covered include benefits of the patient portal, strategies and considerations for setting up a portal, and a breakdown of Stage 3 measures involving patient engagement.

#### Meaningful Use Stage 3 – February 17, 2020 11:00am

This webinar provides guidance to Eligible Professionals (EPs) about the requirements to attest to Meaningful Use (MU) Stage 3 for the NY Medicaid EHR Incentive Program in Payment Year 2021. Topics covered include the Medicaid calculation eligibility criteria, a brief overview of the CMS Regulations, Meaningful Use (MU) Objectives and Measures, Clinical Quality Measures (CQMs), and updates for the final year of the program.

#### Public Health Reporting – February 25, 2020 11:00am

This webinar will provide an in-depth review of the Meaningful Use (MU) Stage 3 Public Health Reporting Objective, which is available to Eligible Professionals (EPs). The webinar will also include information on how EPs can meet the Public Health Reporting Objective.
