Program Background

- New York State Department of Health has partnered with Centers for Medicare and Medicaid Services (CMS) to create FIDA for people who have both Medicare and Medicaid and need long-term care services
- Many potential FIDA participants are currently enrolled in Medicaid managed long term care (MLTC) plans

Benefits include:

- Medicare Part A, including hospital care and home health services; Medicare Part B, including emergency room visits, doctor visits, and wheelchairs;
- Medicare Part D prescription medicines; and
- Medicaid, including home or nursing home care, behavioral health services and some prescription medicines.

Advertising Campaign Overview

- Currently in progress through January 2017
- Increase provider and public awareness of FIDA
- Increase the number of eligible New Yorkers enrolling in FIDA
- Decrease the number of providers encouraging patients to opt out of FIDA
- Decrease the number of eligible FIDA members opting out of the program





Fully Integrated Duals Advantage (FIDA) is a health plan that brings together Medicare and Medicaid. It is centered on you, and it provides all the care you need in one place.

In FIDA, you will be a part of a care team. It may include your doctors, home care aid, your relative, or anyone you trust. The care team will be there to help you make decisions about your health and to make sure you can get all the Medicare and Medicaid services you need. They will connect you to a network of health care and supportive services and help you schedule your doctor appointments.

To join a FIDA plan, you must:

- Be 21 or older:
- Have Medicare & Medicaid
- Reside in Bronx, Kings, New York, Queens. Richmond, or Nassau
- Need long-term care

You will not have to pay extra to be a FIDA plan member. There are no monthly plan premiums, co-payments or deductibles.

Fully Integrated Duals Advantage (FIDA) is a person-centered, integrated health care plan option for people who have both Medicare and Medicaid. FIDA members have a higher level of integrated care and better support to stay independent.

What will FIDA do for you as a provider?

- · Offers you the opportunity to work collaboratively with other providers as part of a care team to develop a single care plan to address your
- · Provides extra support coordinating care for your patients through a Care Team who documents any changes to the patients care plan, and notify you of any other services your patient receives.
- · Helps you ensure your patients get the care and support needed to live safely at home (including appropriate number of home health aide hours), and help avoid hospitalization and nursing


Simplifies the claims process as you bill FIDA plans for both Medicare and Medicaid services.

FIDA at a Glance

The FIDA Program is comprised of four key components:

- Fully integrated delivery of Medicaid and Medicare
- Person centered care the
- · Impr care
- · High a health



- Have one process for all Medicare and Medicaid appeals (except for Part D appeals).
- Access specialists directly, no need for referrals.
- Have help navigating the longterm care system or the appeals process through the Ombudsman Program, called the Independent Consumer Advocacy Network (ICAN).
- Disenroll from FIDA at any time. Medicaid long-term care benefits will continue through a Managed Long-Term Care plan. Medicare benefits will continue through original Medicare or a Medicare Advantage plan, and a Part D plan.

Who is eligible?

To be eligible for FIDA, a person must:

- Reside in any of the New York City boroughs or Nassau County;
- . Be 21 years or older,
- Be entitled to Medicare Part A, enrolled in Medicare Part B, and eligible to enroll in Part D, and receiving full Medicaid benefits; and,
- . Be expected to need of long-term care services for more than 120 days.
