TRANSFER OF ASSETS REGIONAL RATES

A full explanation of the regional rates for use in determining the effect of a transfer of assets for less than the fair market value is discussed in **RESOURCE TRANSFER OF ASSETS ALL CATEGORIES EXCEPT S/CC.**

Regional rates are used to determine the penalty period of restricted Medicaid coverage when a prohibited transfer is made. The rates listed below for each of the seven regions in the state are used for persons who apply for Medicaid as an institutionalized person on or after January 1, 2008.
