## **GRADE 1 COMPLETION INSTRUCTIONS**

- Intervals between doses of vaccine must be in accordance with the Advisory Committee for Immunization Practices (ACIP) Recommended Immunization Schedules for Persons 0 Through 18 Years of Age for all vaccines.
- Field 1 Total Number of Children Enter the total number of students enrolled in grade 1.
- Field 2 Students Without Immunization Record Enter the number of students who do not have an immunization record or any proof of immunity on file. Do not count students without an immunization record in fields 5 through 13. Do not count students who have medical or religious exemptions in this field.
- **Field 3** <u>Medical Exemption</u> Enter the number of students who have a medical exemption from a physician licensed to practice medicine in the State of New York.
- **Field 4**Religious Exemption Enter the number of students who have a written and signed statement from a parent or guardian exempting them from immunization due to religious beliefs that has been approved by the school.
- \* Field 5 <u>Diphtheria, Tetanus, Pertussis (DTaP)</u> Enter the number of students who have received 5 doses of DTaP vaccine or 4 doses with the 4<sup>th</sup> dose on or after the 4<sup>th</sup> birthday. The final dose must have been received at 4 years of age or older.
- \* **Field 6**Polio Enter the number of students who have received 4 doses of polio vaccine (IPV or OPV) or 3 doses with the 3<sup>rd</sup> dose on or after the 4<sup>th</sup> birthday, or who have demonstrated serological evidence of immunity to all 3 serotypes of polio disease. The final dose must have been received at 4 years of age or older.
- \* **Field 7**Measles Enter the number of students who have received 2 doses of measles vaccine, the first of which must have been received no more than 4 days prior to their first birthday, or who have demonstrated serological evidence of immunity to measles disease.
- \* **Field 8**Mumps Enter the number of students who have received 2 doses of mumps vaccine, the first of which must have been received no more than 4 days prior to their first birthday, or who have demonstrated serological evidence of immunity to mumps disease.
- \* **Field 9**Rubella Enter the number of students who have received at least 1 dose of rubella vaccine no more than 4 days prior to their first birthday or who have demonstrated serological evidence of immunity to rubella disease.
- \* **Field 10 Hepatitis B** Enter the number of students who have received 3 doses of hepatitis B vaccine, or who have demonstrated serological evidence of immunity to hepatitis B disease.
- \* Field 11 Varicella (chicken pox) Enter the number of students who have received 2 doses of varicella vaccine, the first of which must have been received no more than 4 days prior to their first birthday, or who have been diagnosed by a physician, physician assistant, or nurse practitioner as having had varicella disease, or who have demonstrated serological evidence of immunity to varicella disease.
  - Field 12 <u>Completely Immunized</u> Enter the number of students who meet all requirements for fields 5 through 11. Those entered in field 2 should not be counted in field 12. The number in field 12 cannot be greater than any number in fields 5 through 11.
  - Field 13 In Process Enter the number of students who are not completely immunized and who have received at least the first dose of each required vaccine series and have age appropriate appointments to complete the series according to the ACIP catch-up schedule.
  - Field 14 <u>Homeless Children</u> Enter the number of children who are considered homeless under McKinney Vento.

## **Medical Exemptions:**

Field 15 <u>Diphtheria, Tetanus, Pertussis (DTaP)</u> – Enter the number of students who are medically exempt from DTaP vaccine.

<sup>\*</sup> Combined vaccines – Students who received vaccines which combine more than one component such as MMR (measles, mumps and rubella), MMRV (measles, mumps, rubella and varicella), DTaP/Hib (diphtheria, tetanus, pertussis and Haemophilus Influenzae type b), Dtap/IPV/Hib (diphtheria, tetanus, pertussis, polio, Haemophilus Influenzae type b) and Hepatitis B/DTaP/IPV (hepatitis B, diphtheria, tetanus, pertussis and polio) should be counted as immunized in each of the separate columns for measles, mumps, rubella, varicella, DTaP, Hib, polio and hepatitis B.
