 - A1561 & S3503 – An act establishing the New York State rural ambulance services task force; and providing for the repeal of such provisions upon expiration thereof.
 - Authorizes the Department of Health through the Bureau of EMS to undertake a Rural EMS Study to identify ways to help Rural EMS sustain its presence - the bill also includes \$50 million dollars for implementation of programs identified by the Rural EMS Study.
 - S1590 Rivera & A151 Gottfried – An act to amend the public health law, in relation to authorizing collaborative programs for community paramedicine services.
 - S1018 Kaminski – An act to amend the real property tax law, in relation to the eligibility of active volunteer firefighters and volunteer ambulance workers for the state of New York mortgage agency low interest rate program.
 - Establishes Low-interest Rate Mortgage Program for Volunteer Ambulance Workers and Firefighters.
